IMPORTANT SAFETY RECALL

Dear Diamond Coach Owner: Build Order Number: 16042

This notice applies to your vehicle, VIN:

NHTSA Recall No: 24V-360

This notice is sent to you in accordance with the National Highway Traffic and Motor Vehicle Safety Act.

Diamond Coach has decided that certain 2023-2024 VIP 2200 Diamond Coach Buses equipped with Freedman Seating Company GO-ES Space Saver Foldaway Seats fail to conform to Federal Motor Vehicle Safety Standard NO. 210, "Seat Belt Assembly Anchorages." The Freedman Seating Company GO-ES Space Saver Foldaway Seats may have a defect which may increase the risk of occupant injury in the event of vehicle collision. The recliner mechanism may not engage when the seat back is fully reclined. The seat back could release when force is applied to the shoulder belt, increasing the risk of injury during a crash.

Your bus, identified above, is affected. The seats will be inspected and repaired by following Freedman recall 24E-026 and service instructions 20240130. The expected time to complete the repair is 15 minutes per seat. To correct this condition please follow the accompanied safety recall letter and service instructions from Freedman Seating Company recall no. 24E-026.

We regret any inconvenience this action may cause you. However, we are concerned about your safety and highly recommend you follow the accompanying safety recall letter from Freedman Seating Company. If you have difficulty getting the repair made through Freedman Seating Company, then Diamond Coach will assist you. Call 1-800-442-4645.

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act..

Freedman Seating Company (FSC) has decided that a defect which relates to motor vehicle safety exists in certain GO-ES Spacesaver Foldaway Seats manufactured between December 11, 2023 and January 31, 2024. The seat back cushion may become disengaged from the dump mechanism when there is a high load applied to the shoulder portion of the seat belt.

Upon receipt of this Recall Notice, FSC is requesting you provide notification of this Product Recall of the subject seats to your Dealer and Customer/Owner.

To correct this condition, we have developed a simple inspection procedure. If the seat does not pass the inspection then there is an easy remedy. A document and video describing the inspection can be found here:

If during the inspection procedure, the seat was found non-compliant, written and video instructions on how to do the repair can be found in the above link. Written instructions are also being sent with this letter.

The repair is expected to take approximately 15 minutes per seat. FSC will reimburse the cost of repairs related to this recall. No parts should be required.



Upon completion of the recall repair work the Customer *must* file a claim with FSC Customer Service for reimbursement referencing FSC Recall #24E026 on the claim.



Inspection Step 1

Bring seat back cushion from stowed position (seat back cushion is folded down against seat cushion) to first engagement point of the back lock (most upright position of the seat back cushion)

Add a piece of tape on the dump cover shroud so that it touches the handle







If handle returns back to original position, no additional work needed


If handle does not return back to the original position then seat will need to be reworked



On the stop bracket adjacent to pin, use a Dynafile or similar tool to grind off up to 1/32" off of the face of the stop
