Dear Mercedes-Benz Owner:

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Mercedes-Benz AG, the manufacturer of Mercedes-Benz vehicles, has decided that a defect which relates to motor vehicle safety exists in certain Model Year 2022–2023 C-Class vehicles. **Our records indicate that your vehicle is included in the affected population.**

What is the issue?



An electrical wire to the pre-fuse box in the passenger-side footwell might not be secured properly. In this case, the electrical resistance of the connection might increase. Due to the high electrical currents potentially flowing through this connection, the temperature of the connection could increase. This might increase the risk of a fire. Additionally, a loss of propulsion without prior warning cannot be ruled out completely, potentially increasing the risk of a crash.

What will your Mercedes-Benz Dealer do?



An authorized Mercedes-Benz dealer will check the wiring of the pre-fuse box on the potentially affected vehicles and re-work it, if necessary. **This vehicle repair will be provided at no cost to you.** While the repair time can be less than **90 minutes**, your dealer can provide you with a better estimate of the overall time for this visit. As a matter of normal service process, the authorized Mercedes-Benz dealer will also check for other repair measures that might be applicable to your vehicle, which may increase the required working time. You will not be charged for other services or repairs unless so requested.

Steps to take.



- Find your nearest authorized Mercedes-Benz dealer at www.mbusa.com/recall to schedule your recall repair.
- Please mention you are scheduling an appointment for Mercedes-Benz recall **2024070005**.
- You may be asked for your VIN, which for your convenience is located at the top of this letter.
