IMPORTANT SAFETY RECALL

Right Side Airbag Connector Partially Engaged

Dear [Name],

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

FCA US has decided that certain [2021-2022 Model Year Jeep Cherokee] vehicles fail to conform to Federal Motor Vehicle Safety Standard (FMVSS) No. 214 - Side impact protection and 226 - Ejection mitigation.

RECALL DESCRIPTION

The right Side Airbag Inflatable Curtain (SABIC) connector on your vehicle ^[1] may not have been properly secured during assembly. An improperly secured SABIC connector may prevent the airbag from deploying in certain types of crashes. **A SABIC that does not deploy may increase the risk of occupant injury in certain types of crashes.**

The condition described above does not comply with Federal Motor Vehicle Safety Standard (FMVSS) No. 571.214 and 571.226 requires SABIC airbag deployment during certain crash events.

YOUR VEHICLE HAS ALREADY BEEN REMEDIED

According to our service records, the SABIC connector has already been repaired on your vehicle. Therefore, your vehicle has been remedied.

This notification is provided for your records only. There is nothing more that you need to do.

WHAT IF I HAVE QUESTIONS REGARDING THIS RECALL?

If you have had previous repairs performed and/or already received reimbursement, you may still need to have the recall repair performed.
