Dear General Motors Customer:

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

General Motors has decided that a defect, which relates to motor vehicle safety, exists in certain 2023 - 2024 model year Chevrolet Colorado and 2023 model year GMC Canyon vehicles. As a result, GM is conducting a safety recall. We apologize for this inconvenience. However, we are concerned about your safety and continued satisfaction with our products.

Why is your vehicle being recalled?

These vehicles may contain a left or right front seat that has a seat belt buckle attachment bolt that may not have been tightened to specification by the seat supplier. If the bolt is not tightened to specification, the affected front seat belt may not perform as intended in certain crash conditions, increasing the risk of injury.

What will we do?

Your GM dealer will tighten left and right front seat belt buckle attachment bolts to the specified torque. This service will be performed for you at **no charge**. Because of service scheduling requirements, it is likely that your dealer will need your vehicle longer than the actual service correction time of approximately 45 minutes.

What should you do?

You should contact your GM dealer to arrange a service appointment as soon as possible.
