Dear Mercedes-Benz Owner:

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Mercedes-Benz AG, the manufacturer of Mercedes-Benz vehicles, has decided that a defect which relates to motor vehicle safety exists in certain model year 2021-2023 S-Class vehicles. **Our records indicate that your vehicle is included in the affected population.**



### What is the issue?

On certain vehicles equipped with an 8-cylinder gasoline engine, the Engine Control Unit (ECU) software might not meet current production specifications. In the event of a mechanical failure in the cylinder deactivation system, the ECU software may cause the engine to overheat or stall. An engine stall could increase the risk of a crash. In addition, an engine that overheats could increase the risk of a fire. Furthermore, exhaust emissions could also be increased.



### What will your Mercedes-Benz Dealer do?

An authorized Mercedes-Benz dealer will update the ECU software. **This vehicle repair will be provided at no cost to you.** While the repair time can be less than **1 hour**, your dealer can provide you with a better estimate of the overall time for this visit. As a matter of normal service process, the authorized Mercedes-Benz dealer will also check for other repair measures that might be applicable to your vehicle, which may increase the required working time. You will not be charged for other services or repairs unless so requested.



### Steps to take:

- Please mention you are scheduling an appointment for Mercedes-Benz recall **2024100007 (CA DMV # 241007)**
- You may be asked for your VIN, which for your convenience is located at the top of this letter.

**For California Only:** A Proof of Correction certificate shall be issued to you by the authorized Mercedes-Benz dealer showing that the vehicle has been repaired under this Recall Campaign. This certificate may be required by the CA Department of Motor Vehicles for vehicle registration or operation.
