This notice applies to your vehicle, [VIN].

Dear INFINITI QX80 Owner:

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. INFINITI has decided that certain Model Year 2025 INFINITI QX80 vehicles fail to conform to Federal Motor Vehicle Safety Standard (FMVSS) number 111, "Rear Visibility". Our records indicate that you own or lease the INFINITI vehicle identified by the VIN on the inside of this notice.

Reason for Recall **Motivo del Retiro**

The rearview camera image may not be displayed when your vehicle is in "Reverse" due to a potential communication concern between the In-Vehicle Infotainment (IVI) system and the Center Information Display (CID) or due to software logic errors in your vehicle's Around View Monitor (AVM) control unit.

These issues would not be compliant with FMVSS 111 S.5.5 "Rear Visibility". The loss of rearview image during a backing event may lead to the increased risk of a crash or injury to a person behind the vehicle.

What INFINITI Will Do **Qué Hará INFINITI**

To remedy each concern, your INFINITI retailer will reprogram your vehicle's IVI and AVM systems. The remedy for both concerns, which is conducted at no charge to you for parts and labor, could take up to two and a half (2.5) hours to complete. However, your INFINITI retailer may require your vehicle for a longer period of time based upon their work schedule.

What You Should Do **Qué Debes Hacer**

Please contact your local INFINITI retailer by following the link below to schedule an appointment to have your vehicle remedied at your earliest convenience. For your convenience, bring this notice with you when you keep your service appointment.
