### INSTALL ALTERNATOR WIRE ALIGNMENT CLIP

**Model:** (2021 - 2022) Street Scrambler, Street Scrambler Sandstorm, Street Twin, Street Twin Goldline  
(2021 - 2024) Bonneville T100, Bonneville T120, Bonneville T120 Black  
(2023 - 2024) Scrambler 900, Speed Twin 900

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Triumph Motorcycles Ltd. has decided that a defect which relates to motor vehicle safety exists in your motorcycle, with the VIN shown above. Triumph is conducting a safety recall to address the condition.

**The reason for this recall notice:** The wires in the connector system may form a bridge if they are exposed to a combination of different factors, such as high temperatures, heavy current loads, and excessive lateral pulling on the wiring. If the connector blades bridge, it poses a potential risk of reaching a thermal threshold beyond the connector system's capacity, leading to deformation of the connector. This may ultimately cause damage to the bike and increase the risk of a fire or crash.

**What Triumph Motorcycles Ltd & your dealer will do:** Triumph Motorcycles Ltd has authorized your dealer to fit a new wire alignment clip, free of charge to you including parts and labor. This repair should take around 5 minutes. However, depending upon the dealer's work schedule, it may be necessary to make your motorcycle available for a longer period.

**What you must do to ensure your safety:** Please make an appointment with your authorized Triumph motorcycles dealer to have this important remedy performed on your motorcycle as soon as possible.

**Federal regulations require that any vehicle lessor receiving this recall notice must forward a copy of this notice to the lessee within 10 days.**

**If you need help:** Please contact your authorized Triumph dealer should you have any questions or encounter any difficulty regarding this recall. In the event your dealer is unable to remedy your motorcycle, please contact Triumph Motorcycles America at 1-678-854-2010.

If an authorized Triumph dealer or Triumph Motorcycle America Ltd, fails or is unable to perform this remedy without charge within a reasonable amount of time, you may contact the Administrator, National Highway Traffic Safety Administration, 1200 New Jersey Avenue SE., Washington, D.C., 20590; or call the toll-free Vehicle Safety Hotline at 1-888-327-4236 (TTY: 1-800-424-9153); or go to <http://www.nhtsa.gov>.

If you previously paid to have this recall performed on your motorcycle, you may be eligible for reimbursement. Please contact Triumph Motorcycles at 1-888-284-6288 for more information, including eligibility requirements.

If you no longer own the motorcycle listed above, please contact Triumph at 1-678-854-2010 and provide any information you can furnish that will assist us in locating the new owner.
