This is an important Safety Recall. The remedy will be performed **FREE OF CHARGE** to you.

**Certain 2024 to 2025 Model Year Porsche Macan Electric Vehicles  
Porsche Recall ARC5 / NHTSA ID 24V-889**

Dear [Redacted],

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. Porsche has decided that certain specific 2024 to 2025 Porsche Macan Electric vehicles fail to conform to Federal Motor Vehicle Safety Standard No. 108 "Lamps, reflective devices, and associated equipment".

**What is the issue?**

Porsche recently determined that the headlamp high beam function exceeds the maximum threshold specified by the applicable regulations. If the high beams are activated, they could create glare and possibly impair the vision of other drivers, increasing the risk of a crash.

**What will Porsche do?**

To remedy this issue, Porsche will update the affected headlamp software **at no charge to you**. The remedy will take approximately one hour to complete, but it may be necessary to make your vehicle available to your Porsche Center for a longer period of time. Your Porsche Center will arrange for alternate transportation if necessary.

**What should you do?**  
  
Please contact any authorized Porsche dealer to schedule an appointment to have this recall performed as soon as possible and to arrange for Porsche-provided alternate transportation if necessary.
