Dear Mercedes-Benz Owner:

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Mercedes-Benz AG, the manufacturer of Mercedes-Benz vehicles, has decided that a defect which relates to motor vehicle safety exists in a model year 2023 EQS vehicle. **Our records indicate that your vehicle is included in the affected population.**

#### What is the issue?



Certain mounting brackets in the roof might not meet current production specifications. In the event of a crash with side-curtain airbag deployment, the airbag cushion material could become damaged by sharp edges on the mounting brackets. This could impair the effectiveness of the side-curtain airbags and increase the risk of injury for vehicle occupants.

#### What will your Mercedes-Benz Dealer do?



An authorized Mercedes-Benz dealer will replace the mounting brackets on your vehicle and check the side-curtain airbags for damage, replacing them if necessary. **This vehicle repair will be provided at no cost to you.** While the repair time can be less than **5 hours**, your dealer can provide you with a better estimate of the overall time for this visit. As a matter of normal service process, the authorized Mercedes-Benz dealer will also check for other repair measures that might be applicable to your vehicle, which may increase the required working time. You will not be charged for other services or repairs unless so requested.

- Please mention you are scheduling an appointment for Mercedes-Benz recall **2025010005**.
