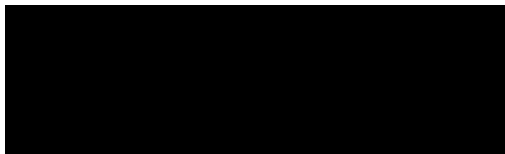

REMEDY NOTICE

Dear Long Beach Container Terminal (LBCT)

This notice applies to your vehicle:

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. Orange EV (OEV) has decided that certain 2018-2023 T- Series Pure Electric Terminal Trucks, 2023-2025 e-TRIEVER terminal trucks, and 2023-2024 HUSK-e terminal trucks **fail to conform to Federal Motor Vehicle Safety Standard No. 108, "Lamps, Reflective Devices, and Associated Equipment."** Our records indicate that you are the current owner of a vehicle affected by this action.

What is the Condition?

The frame extenders on certain T- Series Pure Electric Terminal Trucks, e-TRIEVERs, and HUSK-es manufactured prior to December 12, 2024, create a 100% outboard obstruction of the Backup lamps, Taillamps, Stop Lamps, and Rear Turn Signals. Because of this obstruction, affected trucks do not comply with the visibility requirements in FMVSS 108. **If there is an obstruction to the Backup lamps, Taillamps, Stop Lamps, or Rear Turn Signals, other road users may not be aware of the driver's intentions, increasing the risk of a crash.**

What will Orange EV do?

Orange EV will relocate the rear tail lamps and replace the original LED lights with two multifunction combination lamps that will serve as the backup, tail, stop, and rear turn signal lamps **FREE OF CHARGE** to you. The repair is estimated to take approximately 1 hour to complete.

What should you do?

LIMIT ON-ROAD USE WHILE OPERATING WITHOUT A TRAILER UNTIL YOUR TRUCK IS REMEDIED!

Please contact your Regional Service Supervisor to schedule this repair.

What if you are not the owner or operator of this vehicle?

If you are a vehicle lessor, Federal Law requires that any vehicle lessor receiving this recall notice must forward a copy of this notice to the lessee within ten days.

If you know the current owner or operator, please forward this letter to them.
