## TEC666 VARIO SIDE CASES

### RECALL 24E-029 ISSUED FOR VARIO SIDE CASES FOR R 1300 GS

#### OVERVIEW

- BMW has announced a delivery stop on all Vario Side Cases for the R 1300 GS.
- Any affected parts in dealer inventory should be returned under TEC666.
- Repair kits for the side cases are also affected and should be returned.
- Any open orders for affected parts will be cancelled.
- Please return all incorrect part(s) to your facing Regional Distribution Center (RDC). Submit for return using a YR26 damage claim with order reason BM2. A valid BMW delivery and delivery item number must be entered, and 'TEC666' must appear in the text of your TEC claim. For assistance locating the delivery number, please open an IDS ticket with Dealer Services in the Claims section directed to Returns/Claims/Quality.

#### NHTSA STATEMENT

## MORE DETAILS

- TEC666 is valid from July 16, 2024, through August 31, 2024. The deadline for filing a claim under TEC666 is August 31, 2024.
- All parts must be returned to your facing RDC no later than September 15, 2024.

## VARIO TOP CASES

Vario Top Cases are **not affected** by this update and are confirmed as good parts which can be sold. This includes both the old part 77 43 9 443 542 (repaired using part 77 43 5 B55 147) and the new part number 77 41 4 B0E 654. Repairs on these are finishing in the RDC and orders will soon be placed on the dealer's behalf for their original allocation.
