
CERTAIN 2023-2024 MODEL YEAR CAMRY AND CAMRY HV

The repair quality of covered vehicles is extremely important to Toyota. All dealership technicians performing this recall are required to successfully complete the most current version of the E-Learning course "Safety Recall and Service Campaign Essentials". To ensure that all vehicles have the repair performed correctly; technicians performing this repair are required to currently have completed all the following courses:

- TIC206A - Electrical Repair 1

Always check which technicians can perform the repair by logging on to https://www.uotdealerreports.com. It is the dealership's responsibility to select technicians with the above certification level or greater to perform this repair. Carefully review your resources, the technician's skill level, and ability before assigning technicians to this repair. It is important to consider technician days off and vacation schedules to ensure there are properly trained technicians available to perform this repair at all times.

I. IDENTIFICATION OF AFFECTED VEHICLES

1. CHECK VEHICLE FOR CAMPAIGN ELIGIBILITY

- a. Compare the vehicle's VIN to the VIN listed on the Repair Order to ensure they match.
- b. Check the TIS Vehicle Inquiry System to confirm the VIN is involved in this Campaign, and that it has not already been completed.

<u>NOTE</u>: TMNA warranty will not reimburse dealers for repairs completed on vehicles that are not affected or were previously completed, even by another dealer.




IV. BACKGROUND

The two head restraints on the 60% portion of the rear, fold down seats in the involved vehicles may have poor welds on a bracket that can cause the vehicles not to comply with a federal safety standard. This can affect head restraint performance and increase the risk of injury during certain collisions.

- 1. Removal and Disassembly of the RR Seat Back, (Camry and Camry HV Repair Manual links)
 - a. SEAT: REAR SEAT ASSEMBLY (for Fold Down Seat Type): REMOVAL; 2021 2024 MY Camry [10/2020]
 - b. <u>SEAT: REAR SEAT ASSEMBLY: REMOVAL; 2021 2024 MY Camry HV [10/2020]</u>
 - c. <u>SEAT: REAR SEAT ASSEMBLY (for Fold Down Seat Type): DISASSEMBLY; 2020 2024</u> MY Camry [09/2019 -]
 - d. SEAT: REAR SEAT ASSEMBLY: DISASSEMBLY; 2018 2024 MY Camry HV [07/2017]


Please note the position of the single hog ring during disassembly. There is only one hog ring on this part of the assembly and is the only hog ring required to be replaced in this procedure.







When removing the headrest supports from the adjustable seat, be sure to disengage the two claws to prevent breaking the plastic on these reusable parts.



- 2. Mark the old seat back frame, (1) hog ring, and bezel so as not to reinstall by accident.
- 3. Replace RR Seat Back Frame, (1) hog ring, and bezel with new parts.
- 4. Assembly and Installation of the RR Seat Back, (Camry and Camry HV Repair Manual links)

 - d. SEAT: REAR SEAT ASSEMBLY: INSTALLATION; 2018 2024 MY Camry HV [07/2017]


- Confirm quality of the repair by verifying the marking on the old seat back frame. If the marking is present, it ensures that the old part has not been reinstalled accidentally.
