- 1. Update the Action, and
- 2. update the ESN list.

Description

This Safety Campaign is being issued due to a quantity of 695, C and L Series engines produced at DEP between 27 September 2021 and 7 November 2023 that may have been assembled with Front Damper capscrews that were **not** torqued to specification. This condition may result in the damper coming loose and possibly separating from the engine. If this occurs, it could result in personal injury.

This Safety Campaign authorizes certified service locations to verify the torque of the Front Damper capscrews and, if required, re-torque them to the correct specification and repair any related damage.

Note: This field action provides retroactive coverage for repairs made in anticipation of and prior to the release of this publication.

Action

In order to qualify for repair under this field action, an engine:

- 1. will be covered Regardless of coverage status, and
- 2. must show as OPEN on QuickServe® Online for this field action.

Note: The ESN list is attached for reference.

After verifying that the engine meets the above requirements, perform the following actions:

Note: Visually inspect the Vibration Damper capscrews. If there are NO capscrews missing or there is no damage, please move to Repair Option A. If there are ANY capscrews missing or damaged, please move to Repair Option B.

- Repair Option A (No missing or damaged capscrews)
- A.1. Overcheck all of the Vibration Damper capscrews to 95 Nm. If ALL of the capscrews pass
 the overcheck (they DO NOT move), the correct capscrew torque has been applied during
 engine assembly. No further action is required. Claim the appropriate Admin time and the SRT
 99-008 to close the campaign for the unit inspected.
- A.2. If ANY of the capscrews fail the overcheck (they DO in fact move), the correct capscrew
 torque was NOT applied during engine assembly. One by one loosen and re-tighten each
 capscrews. Please refer to the appropriate Service Manual for the correct tightening method.
 Replace capscrews as is appropriate. Claim the appropriate parts, Admin time and the SRT
 99-008 to close the campaign for the unit inspected.
- Repair Option B (Missing or damaged capscrews):
- B.1. Remove the Vibration Damper and follow the Clean and Inspect for Reuse guidelines in the appropriate Service Manual.
- B.2. Additionally, inspect the Crankshaft to Vibration Damper mating surfaces for damage. In line with pre-authorization requirements as outlined in the Warranty Administration Manual, remove and replace ANY parts that are found to be worn or damaged as a result of the loose Front Vibration Damper.
- B.3. Install the Front Vibration Damper ensuring all the capscrews are correctly tightened.
 Please refer to the appropriate Service Manual for detailed instructions and capscrew tightening method.
- B.4. Claim the appropriate parts, Admin time, and any applicable SRT to close the campaign for the unit inspected.

Note: The results of the inspection and re-torque **MUST** be recorded in the claim narrative.
