











## **INCORRECT CAMERA MODULE INSTALLATION**

 Camera module shown behind the access panel in figure 1 on the driver's side door three in the black box mounted to compartment ceiling.



2. Figures 2 and 3 show the camera module mounted upside down and flush to the compartment ceiling.





## REPLACE CAMERA MODULE WITH PROPER ORIENTATION INSTRUCTIONS

1. The correction is to replace the module. Use the new brackets for correct orientation. (Figures 4 and figure 5)





- 2. Attach new brackets to the original brackets using the 4 screws and nuts provided. (Figures 6 and 7)
- 3. Install new bracket camera module back to compartment ceiling and connect harnesses. (Figure 8)
- 4. Test operation of all cameras.
