Spare Tire Wheel Bolts

This is a reminder that your motorhome has an open safety recall. If this recall does not apply or has already been completed, please email recalls@tiffinmotorhomes.com.

Dear Tiffin Motorhome Owner,

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Tiffin Motorhomes has decided that a defect, which relates to motor vehicle safety, exists in certain **2022 Cahaba Motorhomes, 2024 Convoy Motorhomes, and 2023, 2024 and 2025 GH1 Motorhomes, built between December 20, 2021, and May 8, 2024.**

Certain motorhomes did not have wheel bolts for the spare tire included with the spare tire kit. In the event of the spare tire needing to be installed, an owner may erroneously try to install the spare tire with the wheel bolts from the standard tire. Using incorrect wheel bolts to install the spare tire may cause it to loosen and may detach from the motorhome, leading to an increased risk of a crash.

Tiffin Motorhomes will send a set of wheel bolts for the spare tire to all motorhomes involved in the recall. These wheel bolts should be placed in the motorhome so that they are available if the spare tire needs to be installed.

To receive the spare tire wheel bolts for your motorhome: Please contact Tiffin Motorhomes Recall department by email at recalls@tiffinmotorhomes.com or by phone at 256-356-8661. You will need to have your VIN, located at the top of this notification, and will need to confirm the shipping address for the wheel bolts to be sent. Please refer to this recall, TIF-140. These parts will be shipped to you at no charge.

You may be liable for any progressive damage that results from your failure to complete the recall within a reasonable time after receiving notification.

If you do not own the vehicle that corresponds to the vehicle identification number which appears on this Recall Notification, please return the notification to the Tiffin Motorhomes Recall Department with any information you

can furnish that will assist us in locating the present owner. You may also send an email to recalls@tiffinmotorhomes.com.

If you are unable to have the defect remedied without charge and within a reasonable time after you tender the vehicle for repair, please contact the Tiffin Warranty Department, at 1-256-356-8661, 8:00 a.m. to 3:30 p.m., Central Time. Federal regulations require that any vehicle lessor receiving this recall notice must forward a copy of this notice to the lessee within ten days.
