Dear Cummins Customer:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Cummins Inc. has decided that a defect which relates to motor vehicle safety exists in certain Cummins X15 engines that were manufactured between June 10, 2024 and August 30, 2024 and certain re-manufactured X15 engines built between August 13, 2024 and August 14, 2024.

This notice applies to your Cummins X15 engine(s) listed in the table on the enclosed engine list.

**WHY IS A RECALL BEING CONDUCTED?**

The fuel pump barrels installed on some of the engines in the subject population may have been built using low fatigue strength parts, making them susceptible to fracture. If a fuel pump barrel fractures, an external fuel leak and sudden loss of fuel pressure may occur, potentially causing the engine to stall without the ability to restart. An engine stall without the ability to restart may increase the risk of a crash.

**WHAT ARE WE DOING ABOUT THE PROBLEM?**

Cummins has released field Safety Campaign C7083 'X15 Fuel Pump Head Replacement Safety Campaign' to correct this condition by replacing the suspect barrels (2 barrels per fuel pump) with new verified parts. Repair parts are currently available at Cummins Distributors and authorized Warranty Dealers. The repair will be completed free of charge and most applications will require approximately 2 hours to complete.

**WHAT SHOULD YOU DO?**

Contact the nearest Cummins Distributor or authorized Warranty Dealer to arrange to have this campaign performed on your engine. The distributor or dealer will work with you to schedule the best date to complete this repair.

In the meantime, until the campaign is completed, operators are advised that reduced engine performance, a warning lamp, or the visual observation or smell of diesel fuel around the vehicle may be symptomatic of a fuel pump barrel fracture. If a fuel pump barrel fracture is suspected, Cummins recommends stopping the engine when it is safe to do so and seeking immediate repair.

***Federal law requires vehicle lessors receiving this recall notice to forward a copy of this notice to the lessee within ten (10) days. Also, it is a violation of Federal law for a dealer to deliver a new vehicle or equipment covered by this recall notice under a sale or lease until the defect has been remedied.***

If you previously paid to have this recall performed on your vehicle, you may be eligible for reimbursement. Please contact your local Cummins Distributor or authorized warranty dealer.
