### Dear **CUSTOMER NAME**,

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Bugatti Automobiles SAS has decided that certain 2016-2023 Chiron vehicles fail to conform to Federal Motor Vehicle Safety Standard (FMVSS) number 208, "Occupant Crash Protection".

Our records show that you are the owner of a vehicle potentially affected by this safety concern.

What is the issue? While driving at low speeds, the vehicle software may not properly

generate the audible safety belt warning signal for the driver. Without an audible warning, the driver may be unaware that their seat belt is not

fastened, which could increase the risk of injury during a crash.

What will we do? To correct this defect, your authorized BUGATTI Partner will perform a

What should you do? No BUGATTI should ever be driven without the safety belt being correctly

buckled. It is a legal requirement in line with FMVSS 208 that the compliant audible warning is installed. As soon as the required software is released BUGATTI will mail you a second letter to inform you that it is available and at that point, we would ask you to contact your authorized BUGATTI Partner without delay to schedule a repair appointment and refer to BUGATTI's recall number BUGCR036. Please note that all transport-related costs to your nearest BUGATTI Partner will be covered by BUGATTI for this

recall.
