### Subject: Intellipark Parking Valve Module

This notice is sent to you in accordance with the requirements of the *National Traffic and Motor Vehicle Safety Act*.

Daimler Truck North America LLC (DTNA), on behalf of its Freightliner Trucks Division, and wholly owned subsidiary, Thomas Built Buses (TBB), has decided that a defect, which relates to motor vehicle safety, exists in certain model years 2024-2025 Freightliner Business Class M2 vehicles, and TBB Saf-T Liner C2 and Saf-T Liner C2 Jouley buses. See below for additional detail on vehicle applicability:

The park valve module rubber ball seal may fracture or leak, allowing the vehicle to unintentionally move after attempting to park the vehicle, or allowing the parking brake to engage, increasing the risk of a crash.

This is the first of two notices you will receive regarding this subject. This letter is to inform you of an upcoming Recall to correct the issue noted above. Daimler Truck is currently validating the final repair and securing replacement parts. **There is no action for you to take at this time.**

A second notice will inform you when the final, **free remedy** is available. **When you receive the second notice**, please contact your authorized Daimler Truck North America dealer to schedule the repair for your vehicle.

If you do not own the vehicle that corresponds to the identification number(s) which appears on the Recall Notification, please return the notification to the Warranty Campaigns Department with any information you can furnish that will assist us in locating the present owner. If you have leased this vehicle, Federal law requires that you forward this notice to the lessee within ten days. If you are a subsequent stage manufacturer, Federal law requires that you forward this notice to your distributors and retail outlets within five working days.
