This notice is being sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Reason For This Recall

Winnebago Motorhomes has decided that a defect related to motor vehicle safety exists on certain:

2024 - 2025 Ekko and 2025 View / Navion

These motor homes were manufactured **October 19, 2023**, through **August 23, 2024**. Our records indicate that you have purchased a vehicle with the serial number which appears above.

On certain motorhomes, the air conditioner soft start module(s) installed may potentially overheat, an air conditioner soft start module that overheats increases the risk of a fire.

Interim Notice

This interim recall notice is to inform you of an upcoming recall to correct the issue identified above. If any concerns arise, please contact your Winnebago motor home dealer. On affected vehicles, Winnebago dealers will replace the air conditioner soft start module(s). **This repair** will be done at no charge to you.
