### URGENT SAFETY RECALL

This is an important Safety Recall. The remedy will be performed **FREE OF CHARGE** to you.

Certain 2025 Model Year Porsche Taycan Vehicles  
Porsche Recall ARB8 / NHTSA ID 24V-730

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. Porsche has decided that certain specific 2025 Porsche Taycan vehicles fail to conform to Federal Motor Vehicle Safety Standard No. 111, "Rearview Visibility".

### What is the issue?

Porsche recently determined the rear view camera installed on your vehicle may not activate within the response time required by the applicable regulation. More specifically, if the front visual park assist activates shortly before the vehicle is put into reverse gear, then the reversing camera may not activate in time, increasing a risk of a crash while reversing the vehicle.

### What will Porsche do?

To remedy this issue, Porsche will update the affected software **at no charge to you**. The remedy will take approximately one day to complete, but it may be necessary to make your vehicle available to your Porsche Center for a longer period of time. Your Porsche Center will arrange for alternate transportation if necessary.

### What should you do?

The remedy for this Recall is not yet available. Porsche will contact you again via letter when the remedy is available.
