URGENT SAFETY RECALL

This is an important Safety Recall. Please pause driving your vehicle until it is inspected.

Certain 2023-2024 Model Year Porsche 911 and 718 Vehicles
Porsche Recall ARC4 / NHTSA ID 24V-809

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. Porsche has decided that a defect, which relates to motor vehicle safety, exists in certain specific 2023 to 2024 Porsche 911 and 718 vehicles.

What is the issue?

Porsche recently determined the center lock wheel fastening system installed on your vehicle may have been constructed out of specification, and as a result may fracture. If a center lock fractures this could result in a loss of steering control, increasing the risk of a crash.

What will Porsche do?

To remedy this issue, Porsche will inspect the date code on each of your center locks, and replace them if needed **at no charge to you**. The remedy will take approximately one day to complete, but it may be necessary to make your vehicle available to your Porsche Center for a longer period of time. Your Porsche Center will arrange for alternate transportation if necessary.

What should you do?

The remedy for this Recall is not yet available. Porsche will contact you again via letter when the remedy is available.

Porsche recommends, out of an abundance of caution, **not to drive your vehicle until the remedy is carried out**. Porsche-provided alternate transportation is available at your Porsche Center.
