CUSTOMER/RESELLER NOTIFICATION

This Customer Notification is sent to you, the Customer/Reseller, in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

REASON FOR THIS RECALL

PowerStop has determined a noncompliance which relates to motor vehicle safety exists with its braided stainless-steel brake hoses. Following a thorough investigation, PowerStop has determined that these brake hoses fail to conform to Federal Motor Vehicle Safety Standard (FMVSS) No. 106 – Brake Hoses and could increase the risk of a crash.

As a result, PowerStop is conducting a safety recall. While PowerStop has not received any reports of injuries as a result of this product, the company is taking proactive steps to remove all part numbers that do not conform with FMVSS No. 106.

Our records indicate your company purchased one or more of the involved PowerStop brake hose products shipped between 02/1/19 and 06/14/24. **If these products are still in your inventory, you must not sell or ship any part numbers (components and kits) listed in Exhibit A. It is a violation of federal law to sell any of the listed products covered by this recall. Please return all recalled product to PowerStop for full credit for product cost and shipping fees.**

WHAT WE WILL DO

PowerStop will refund end customers the cost of the purchased PowerStop brake hoses as well as an additional fixed fee to reimburse the vehicle owner for the estimated cost of removal and replacement of these brake hoses.

In order to receive reimbursement for the purchased PowerStop brake hoses, the end customer must provide proof of purchase for PowerStop brake hoses included in this recall.

In order to receive an additional fixed reimbursement of \$250.00 for estimated cost of removal of PowerStop brake hoses and installing new brake hoses, the end customer must submit a valid receipt from the installer for the repair work or provide visual images of PowerStop brake hoses off the vehicle.

Please note: The request for the \$250.00 reimbursement for estimated labor costs related to brake hose replacement must be submitted within ninety (90) days from the time proof of purchase for the PowerStop brake hoses was submitted.

WHAT YOU SHOULD DO

In addition to immediately ceasing all selling and shipping of part numbers listed in Exhibit A, your company has the option of a) sending notification to your end customers who have purchased this product for their vehicle of either this letter or a summary of its contents, or b) provide PowerStop or our claims management partner, Sedgwick, with this list of end customers for us to contact and notify purchasers of these brake hoses directly. If you prefer to have Sedgwick handle communication to end customers on behalf of your company, please let your PowerStop account representative know, and they will provide the appropriate email address to do so.
