**Subject:** Front Rail Gear Welds May Fail

This letter serves to acknowledge Reading Truck Group LLC's notification to the National Highway Traffic Safety Administration (NHTSA) of a safety recall which will be conducted pursuant to Federal law for the product(s) listed below. **Problem Description:**

Reading Truck Body, LLC (Reading) is recalling certain 2021 Rail Gear HD trucks. Welds may crack and fail, allowing the front rail gear to shift and contact the road.

**Consequence:**

The rail gear dragging on the ground can cause a loss of control, increasing the risk of a crash.

**Remedy:**

Owners are advised not to drive their vehicles until the remedy has been completed. Reading will reweld the joints between the rail gear and chassis, free of charge. Owner notification letters are expected to be mailed July 18, 2025. Owners may contact Reading's customer service at 1-610-775-3301.

**Please be reminded of the following requirements:**

Copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall, including a copy of the final owner notification letter and any subsequent owner follow-up notification letter(s), are required to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).

Please be reminded that under 49 U.S.C. § 30112(a)(3), it is illegal for a manufacturer, to sell, offer for sale, import, or introduce or deliver into interstate commerce, a motor vehicle or item of motor vehicle equipment that contains a safety defect once the manufacturer has notified NHTSA about that safety defect. This prohibition does not apply once the motor vehicle or motor vehicle equipment has been remedied according to the manufacturer's instructions.

As stated in 49 U.S.C. § 30118(f), submission of eight consecutive quarterly reports followed by three annual reports is required. As described in 573.7, submission of the first of eight consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. Therefore, the first quarterly report will be due on, or before, 30 days after the close of the calendar quarter. The first of three consecutive annual status reports will be due on, or before, 1 year after the eighth quarterly report was submitted.
