Problem Description:

Altec Industries, Inc.(Altec) is recalling certain 2022-2023 AA55, 2023 AM55, AN46, and AN55 vehicles. A check valve that retains oil in the boom hoses may not have been installed, allowing a vacuum to form and reducing the upper boom's insulation.

Consequence:

Reduced insulation can conduct electricity to the operator or others touching the vehicle, increasing the risk of injury and death.

Remedy:



Altec will provide instructions to owners on how to inspect their vehicles for the check valve. Altec service will install the check valve as necessary, free of charge. Owner notification letters are expected to be mailed February 20, 2026. Owners may contact Altec customer service at 1-877-462-5832. Altec's number for this recall is CSN 3272.

Please be reminded of the following requirements:

You are required to submit a draft owner notification letter to this office no less than five days prior to mailing it to the customers. Also, copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall, including a copy of the final owner notification letter and any subsequent owner follow-up notification letter(s), are required to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).

Please be reminded that under 49 U.S.C. § 30112(a)(3), it is illegal for a manufacturer, to sell, offer for sale, import, or introduce or deliver into interstate commerce, a motor vehicle or item of motor vehicle equipment that contains a safety defect once the manufacturer has notified NHTSA about that safety defect. This prohibition does not apply once the motor vehicle or motor vehicle equipment has been remedied according to the manufacturer's instructions.

As stated in 49 U.S.C. § 30118(f), submission of eight consecutive quarterly reports followed by three annual reports is required. As described in 573.7, submission of the first of eight consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. Therefore, the first quarterly report will be due on, or before, 30 days after the close of the calendar quarter. The first of three consecutive annual status reports will be due on, or before, 1 year after the eighth quarterly report was submitted.
