Description of the Noncompliance : Products in the recall population were shipped with attached recall registration cards which were designed for Canada and did not comply with applicable FMVSS requirements,
FMVSS 1 : 213 - Child restraint systems
FMVSS 2 : NR

Description of the Safety Risk : Customers purchasing vehicles within the recall populations would not have received recall registration cards compliant to FMVSS requirements. This could render it less likely that they would register their products making it less likely that they would receive direct notice in the event of a recall. This potential is partly mitigated because Evenflo has the address to which each product was shipped and would use that information to increase notice effectiveness in the event of a recall.

Description of the Cause : There are a variety of system and process factors which contributed to the possibility that Canadian intent product could be shipped to US retail purchasers in different scenarios. The root cause is failure to include a fail safe check to prevent the shipment of Canadian intent product to US addresses.

Identification of Any Warning that can Occur : The recall registration cards shipped with product in the recall population clearly indicated that they are intended for Canadian residents.

Chronology :

On January 7, 2025, Evenflo became aware of the possibility that car seats (or travel systems including car seats) configured for the Canadian market may have been shipped to retail customers with addresses in the United States. Such car seats or other products had designated model numbers specific for seats intended for Canadian sale. An investigation was initiated.

January 14, 2025, with specific examples of car seats intended for Canada delivered to US customers confirmed, Evenflo initiated a dynamic testing program to evaluate relevant Canadian model car seats for compliance with US standards (FMVSS 213). Concurrently, efforts to identify all instances of such deliveries continued.

February 28, 2025, Evenflo completed its dynamic testing and concluded that Canadian car seats shipped to US customers all complied with applicable requirements for product performance. However, Evenflo also identified that the recall registration cards included with Canadian model car seat products did not fully comply with the requirements of FMVSS 213. Activities concerned with confirming the population of relevant product shipments continued.

March 3, 2025, Evenflo management made the determination that products in the recall population presented a non-compliance related to the recall registration card and that a recall should be initiated to remedy that non-compliance.

Description of Remedy :

Description of Remedy Program : Evenflo will mail notice of the recall and a compliant recall registration card to each purchaser at the shipping address contained within its records.

How Remedy Component Differs from Recalled Component : The remedy registration cards are drafted to be compliant with US requirements under FMVSS 213. The cards originally provided with the recalled product were drafted for compliance with Canadian requirements, which are different.

Identify How/When Recall Condition was Corrected in Production : This is not a production issue. Rather, it is an issue which arises from shipment of products to US purchasers which were configured to Canadian (not US) requirements. Evenflo has implemented various process and system changes to prevent this from occurring in the future.
