Description of the The internal harness height range on the forward-facing installation label of Noncompliance: each affected product is incorrect and inconsistent with the height range correctly stated in the instruction manual included with the child restraint.

> The height range incorrectly stated on the forward-facing installation label of each affected product states 43-57 in. (110.1-144.8 cm) and the height range correctly stated in the instruction manual says 34-49 in. (87-125 cm).

Each of the affected products have been determined to be noncompliant to FMVSS No. 213 S5.5.2(f)(4). The internal harness of the affected child restraint systems are not intended to be used by a child with a height taller than 49 inches (125 cm), and therefore the forward-facing installation label is incorrect.

Chronology:

2/13/2025 - A Child Passenger Safety Technician (CPST) contacted Dorel Customer Care alleging a discrepancy between the height range stated on the forward-facing installation label of a BC159 Safety 1st Comfort Ride when compared to the instruction manual included with the child restraint and wanted to know which height range was correct.

2/19/2025 - Regulatory Compliance team begins investigation of the discrepancy reported by the CPST.

2/21/2025 to 3/5/2025 - Regulatory Compliance team investigation continues. Regulatory Compliance team confirms the height range on the forward-facing installation label to be incorrect and inconsistent with the height range correctly stated in the instruction manual included with the child restraint. However, it was unknown whether the child restraint might nevertheless comply with FMVSS No. 213 when evaluated with the H3-10Y0 test dummy (as dictated by the fact that the incorrect height range on the product label exceeds 49 inches (125 cm)). The first available test date at Calspan using the H3-10Y0 test dummy is reserved for 3/5/2025.

3/5/2025 - FMVSS No. 213 dynamic testing using H3-10YO test dummy is completed at Calspan using lap belt only and lap belt with top tether installation. Testing with top tether met requirements however testing without top tether showed that the child restraint did not meet the FMVSS No. 213 injury criteria, confirming that the height shown on the product label is incorrect. The determination of noncompliance to FMVSS No. 213 S5.5.2(f)(4) on affected models is made at this time.

Description of Remedy:

Description of Remedy Program: A recall kit with a new forward-facing installation label (part number

4360-8704B) stating the correct height range will be sent free of charge to registered owners and recall responders of affected products. The recall kit will also include the owner notification letter and instructions for how to place the new forward-facing installation label over the noncompliant

label on their affected product.

How Remedy Component Differs Affected products include a forward-facing installation label with part from Recalled Component: number 4360-8704 or 4360-8704A. The recall kit will include a new forward-facing installation label with part number 4360-8704B.
