not being included in the recall population.

### **Chronology:**

CC321 production started in February 2023. Dorel received the first case of a child placing foam into their mouth in June 2023. Then in October 2023, three additional cases were reported. Production of CC321 models ended in December 2023. Dorel continued to monitor this issue and include foam in the mouth cases in quarterly EWR reports. On December 30, 2024, NHTSA ODI contacted Dorel requesting additional information. On January 14, 2025 Dorel met with ODI at NHTSA headquarters and reviewed the CC321 headrest design. On April 11, 2025 Dorel spoke with NHTSA ODI staff to discuss their concerns with the CC321 headrest foam. On April 12, 2025, Dorel reviewed the latest complaint data and the determination was made to file this Part 573 and recall all CC321 models. Please note there have been no claims of injury or medical treatment required.

### **Description of Remedy:**

replacement headrest pad assembly that will securely cover the foam

headrest to prevent access by a child.
