Evenflo has received 11 reports indicating children picked off pieces from the foam headrest of the versions of the Revolve360 Slim in the recall population and placed them in their mouth or nose.

A child breaking off pieces of the phone headrest may ingest them, creating a choking hazard.

Description of the cause:

The headrest is accessible underneath the soft goods cover. The field experience demonstrates that the tape employed to protect against a child picking off pieces of foam does not extend sufficiently far to be fully effective.

Chronology

On October 2, 2023, Evenflo first received a report of a child picking at the foam of the product headrest and placing in in their mouth. Through the second quarter of 2025, Evenflo had received eight reports of foam access and ingestion. On August 4, 2025, Evenflo participated in a meeting with NHTSA's Office of Defect Investigations in which concerns were raised about these reports. ODI requested additional information and data. On August 14, 2025, Evenflo participated in a follow-up meeting in which it responded to pending questions and the matter was further discussed. Further investigation ensued. Evenflo is currently aware of a total of 11 reports that children accessed foam in the headrest of the variants of the Revolve360 Slim constituting the recall population and placed it in either their mouth or nose. Evenflo is also aware of twelve additional reports of children accessing the foam (though not ingesting it). On September 15, 2025, management made the determination that the potential for access and picking at the headrest foam constitutes a defect and that action should be taken accordingly.

Evenflo will supply consumers for which it has contact information (whether by reason of product registration or otherwise) with a remedy kit including an additional tape seal. When installed by the consumer according to the accompanying instructions, the tape seal will protect against child access to the headrest foam.

After implementation of the remedy, the entire bottom edge of the headrest will be protected from child access and picking.
