Joyson initiated an investigation following reports of field incidents involving head side airbags with HPH-A inflators provided by motor vehicle manufacturers in 2024. All reported incidents occurred in unoccupied vehicles with no reported injuries. Since then, Joyson has provided regular updates to NHTSA regarding the ongoing technical investigation. On October 10, 2024, General Motors voluntarily recalled 2,061 vehicles containing head side airbags supplied by Joyson. On January 16, 2025, Chrysler voluntarily recalled 6,066 vehicles containing certain head side airbags supplied by Joyson. Joyson submits this information based on the recalls initiated by GM and Chrysler.
