The Blister Helmet failed the penetration tests at all temperatures and when submerged in water. FMVSS No. 218 label was misplaced.

Description of the safety risk, including crash, fire, death, injury:

Purchasers are at risk for head trauma from piercing objects if they suffer an accident.

Description of the cause:

Chinese manufacturers generally used inferior manufacturing methods and materials, which resulted in an ABS helmet without the ability to protect against punctures. The adhesive allowed the outershell to separate from the protective interior. Additionally, neither the outershell nor the cushioned interior has enough structural integrity based on the materials used to protect against punctures.

Description of remedy program:

Micro DOT intends to carry out all required disclosures and has prepared a notice of recall to provide to its distributors to give to customers. Micro DOT intends to put a notice on its website of the recall and the dates for which the recall remedy will be available. Micro DOT's remedy is to offer a replacement helmet to customers which they can acquire by contacting Micro DOT with proof of purchase and directly sending in the defective helmet with a correct return address for Micro DOT to send a replacement helmet. Distributors will receive replacement stock of non-defective helmets.

How remedy component differs from recalled component:

The replacement helmets for consumers are made of fiberglass and have undergone independent testing to verify they do not have the same defects as the ABS helmets, which are subject to recall.

Identify how/when recall condition was corrected in production:

The failure of the ABS-style motorcycle helmets has resulted in the discontinuance of that line of motorcycle helmets.

Reimbursement Plan

Description of reimbursement program:

Since the subject of the recall is motorcycle helmets whose defect is catastrophic failure when encountering a puncturing force, no helmet would be able to be repaired. Micro DOT is unaware of how any owner would be able to take pre-notification remedies because the helmets are in an irreparable state and need full replacement. As a result, any owner who presents a Blister or Twister-style ABS helmet, pre-notification, for repair will instead receive a replacement DOT-certified Micro DOT helmet of reasonably equivalent value. Micro DOT will cover the cost to send in the helmet for replacement and the cost to ship the replacement to the owner.

Period of reimbursement:

The period for reimbursement extends from the time of purchase of the Blister or Twister-style helmet indefinitely.

Costs to be reimbursed:

The costs to be reimbursed are the costs of the owner to send in the helmet and to send the replacement helmet back to the owner. The actual replacement will be provided at no cost.
