**Description of the Safety Risk :** the owners can potentially exceed weight limit of the chassis those equipped with the 'pop-top' version which can extensive damage to tires, suspension, brakes. It is also possible that exceeded weights could cause issues with the vehicle's stability control system and an increased risk of a crash and injury.

**Description of the Cause :** Since 'pop-top' option weights more than the non 'pop-top' version by 191lbs, the owners can potentially exceed weight limit to the 'pop-top' version which can extensive damage to tires, suspension, brakes.
