Description of the Defect : Casting irregularities are seen in the top portion of the caliper and noted in the manufactures bulletin.

FMVSS 1 : NR

Description of the Safety Risk : On affected models, during use, it is possible the upper guide pin of the brake caliper may crack. If the front brake caliper cracks at the upper guide pin it may reduce the braking system's effectiveness.

Description of the Cause : Irregularities were found in the casting structure of one of the brake supplier's sub-suppliers. In the worst case, this can lead to the front brake caliper cracking in the area around the upper guide pin.

Chronology :

In the course of ongoing market monitoring, the first case of the mounting point of the brake caliper guide pin breaking was from supplier J. Juan, in April 2024. KTM Sportmotorcycle GmbH and the supplier began investigating the components and condition in April 2024. KTM Sportmotorcycle GmbH and J. Juan investigated the conditions, and the final technical confirmation was sent on October 21, 2024. No injuries or deaths have been reported.

Description of Remedy :

Description of Remedy Program : Official KTM/GASGAS and Husqvarna dealers will inspect the front brake mounting caliper and determine which version of the caliper is installed. If the affected version of the caliper is identified, it must be replaced with the corrected version.

How Remedy Component Differs from Recalled Component : Casting irregularities are seen in the top portion of the caliper and noted in the manufactures bulletin. Vehicles produced later may also have "centering holes" that are not affected by the recall or replacement.

Identify How/When Recall Condition was Corrected in Production : The part manufacturer changed the sub-suppliers to the sub-supplier which had no casting issue.

Description of Recall Schedule : KTM North America,dba GASGAS North America and Husqvarna Mobility North America are notifying all registered owners of the above-affected motorcycles by mail and all authorized dealers via GASGAS Dealernet and Husqvarna Dealernet, an internet based communication portal.
