#### **Chronology** :

End of 2023: First report of an alleged failure of an area view system in a foreign market. VW informed the Supplier, analysis and investigation was started

January - May 2024: Analysis regarding potential root cause and contributing factors of the alleged failure, including analysis of field return part.

June 2024: Analysis of VW field return parts showed potential issue with boot loader of the control unit under certain voltage and temperature conditions.

July 2024 – January 2025: Ongoing analysis of reported claims, including clarifying and understanding contributing factors, potential failure modes and potentially affected models. Analysis appeared to indicate that certain part tolerances may influence the occurrence of the failure, but the exact parameters could not be precisely defined within the affected population. Additionally, while most failures appear to occur after some level of exposure in the field to environmental conditions and/or driving behaviors, a failure at initial retail sale could not be ruled out.

February 5, 2025: The Volkswagen and Audi Product Safety Committees determined that the issue constitutes a non-compliance in the US and decided a non-compliance recall.

#### **Description of Remedy :**

Description of Remedy Program :	At no cost to owners, authorized dealers will provide updated camera control unit software. Neither Volkswagen nor Audi will offer a reimbursement plan under this recall because the affected vehicles are within the new vehicle limited warranty period.
How Remedy Component Differs from Recalled Component :	The new software version prevents malfunctions from occurring when the control unit is started.
