GM opened a product investigation into the condition on January 10, 2025 after GM's Australia team identified a potential discrepancy in the rear outboard head restraint illustration in owner's manuals provided with 2025 model year LYRIQ vehicles sold in Australia and New Zealand. GM's investigation found that the head restraint description for the China market LYRIQ, which has a unique design, was inadvertently used in manuals for the U.S. and other markets. GM is not aware of any accidents or injuries related to this condition. On March 20, 2025, GM's Safety Field Action Decision Authority (SFADA) decided to conduct a noncompliance recall.
