Descriptive Information : Approximately 51 motorcycles were manufactured with a steering damper that may not have been produced by the supplier according to specifications.

Motorcycle manufacturing information and supplier production records were reviewed to determine the number and production date range of potentially affected motorcycles.

Recall component difference to non-recall component: Potentially affected motorcycles were manufactured with a steering damper that may not have been produced by the supplier according to specifications.

Description of Defect :

Description of the Defect : This safety recall involves the steering damper which may not have been produced by the supplier according to specifications. Specifically, the valve pin inside the damper may not have been properly fastened within the housing.

As a consequence, the valve pin may wander from its location, which could reduce the flow path capacity within the damper.

If this occurs, the movement of the steering damper may become stiff.

Description of the Safety Risk : Increased steering effort by the rider would be needed at low speeds (less than 30 km/h), which could increase the risk of a crash.

Owners will be notified by First Class mail and instructed to take their motorcycle to an authorized BMW motorcycle dealer to have the remedy performed for free. If this condition were to occur to a potentially affected motorcycle prior to this recall, the remedy would be covered by the BMW New Vehicle Limited Warranty program. Therefore, reimbursement for a pre-notification remedy re Part 573.13 and Part 577.11 is not necessary.
