Descriptive Information : The Federal Tag on these select models is inaccurate and does not have the correct UVW (unloaded vehicle weight rating) which also affects the CCC (cargo carrying capacity). The population of 'in scope' product was determined by a weight report audit. The population of affected product differs from non recalled product in that the weight of the RV was miscalculated. There are a total of affected units is 152 Alliance Avenues, model year 2025 and model 23ML

Description of Defect :

Description of the Defect : The RVs UVW was miscalculated which resulted in an inaccurate Federal Data tag that displays incorrect UVW as well as cargo carrying capacity.

FMVSS 1 : NR

Description of the Safety Risk : Inaccurate weight of the RV which provides a false ccc that can lead to an end user unknowingly overloading the RV which could result in adverse towing conditions, up to and including a crash and/or death.

Description of the Cause : A miscalculation of the weight of the RV. The weight was established with the landing legs down which bears some of the weight and gives an inaccurate scale reading which drives the creation of the federal id tag

Identification of Any Warning that can Occur : Adverse towing due to overloading.

on 4/8/2025 A weight report audit lead to findings of a miscalculated UVW on the RV. Upon identifying this concern, a hold put on product to further investigate the root problem. on the afternoon, all of this model was put on hold and the weight / fed tags were corrected. This information (of fixed coaches) allowed us to develop the scope which then on 4/9, the recall was submitted.

Description of Remedy :

Description of Remedy Program : The remedy is to ensure that this model of RV is weight properly and without the landing legs bearing weight during the weighing process. Alliance RV will issue a recall to replace the inaccurate Fed tags that will have accurate weights on it for safe loading and handling. The reimbursement plan will be in line with our global reimbursement standards.

How Remedy Component Differs from Recalled Component : The remedied RVs (satisfied recall) will have proper weights on the data tag which will allow for an accurate CCC for loading and towing.

Identify How/When Recall Condition was Corrected in Production : the recall condition was corrected by ensuring this model is weight properly and that the landing legs are not down during the weight process which provides false weight readings.

Description of Recall Schedule : Alliance RV will immediately develop instructions for both dealers and retail owners to be submitted for approval (when required) and sent out to kick off the recall to allow opportunity for this to be addressed through our normal warranty and recall process.
