Description of Defect :

Description of the Defect : A manufacturing error may cause the passenger occupant detection system (PODS) to detect a malfunction and switch off the passenger airbag even though the seat may be occupied. As designed, a warning light in the instrument panel comes on together with an acoustic warning sound and an error message is displayed in the instrument cluster. The airbag indicator light shows "Passenger Airbag OFF".

Description of the Safety Risk : In the event of a crash, there could be an increased risk of injury to the occupant seated in the front passenger seat if the passenger airbag is switched off/not working.

Description of the Cause : The crimp connection of the seat cushion heating mat at the transition of the connection cable to the heating wire may not have been correctly executed in the affected vehicles.

Identification of Any Warning that can Occur : Should a malfunction occur, vehicle occupants will be alerted by illumination of the airbag warning light, an error message displayed in the instrument cluster and by the status of the Passenger Airbag OFF indicator light. In this case the customer should take their vehicle as soon as possible to a dealership for inspection/repair.

Description of Remedy Program : The affected seat cushion on the front passenger seat will be removed and replaced with the new optimized seat cushion.

Audi will not offer a reimbursement plan under this recall as the affected vehicles are still covered under Audi New Vehicle Limited Warranty.

How Remedy Component Differs from Recalled Component : Repair set includes a foam part with glued-on heat mat incl. optimized crimp connection (significant increase in robustness)

Identify How/When Recall Condition was Corrected in Production : The production deviation of the crimp connection mentioned above has been optimized since 03/23 and has no longer occurred since then.
