Description of Defect :

Description of the Defect : According to MORryde's Recall 25E026: "This is a bracket that is used on the side of an RV that has a receiver for a removable step assembly to clip into. This receiver is installed using a thread locking fluid to retain the assembly. It was found that there were parts that did not have this thread locking compound installed during assembly."

Description of the Safety Risk : According to MORryde's Recall 25E026: "If the receiver becomes loose while being used, it can disengage from the bracket allowing the step assembly to fall from its use location. This has the potential to cause personal injury if the step is being used when this happens."

Description of the Cause : According to MORryde's Recall 25E026: "Failure to use thread locking fluid during assembly process."

Identification of Any Warning that can Occur : According to MORryde's Recall 25E026: "The receiver of the bracket can be spun which can cause it to unscrew and detach from the installed bracket".

Chronology :

On April 10, 2025, Forest River's Office of Corporate Compliance ("OCC") received a part 573 notice, recall number 25E026 and notice from MORryde indicating a recall of their detachable steps/step bracket. OCC opened a research item.

On April 14, 2025, OCC identified through discussion with the plants that had purchased (according to MORrydes Sales Records) the models affected.

On April 22, 2025, Forest River's Office of Corporate Compliance ("OCC") discovered that a clerical error was made which included vehicles manufactured prior to the scope date set forth by MORryde. The new USA affected vehicle count was 4270, the new scope is 4179.

Description of Remedy :

Description of Remedy Program : Forest River will provide all parts and labor free of charge to Consumers and Dealers. An authorized Forest River dealer will need to perform the remedy to inspect that the stainless receiver is tight and will not turn left or right Apply a liberal amount of GREEN Loctite 290 Thread Locker (provided) to the end of the bolt inside the center of the receiver and allow it to cure for 24 hours. End of required action. If the stainless receiver is not tight and can be unscrewed without the retention bolt turning, then unscrew/remove the stainless receiver and apply RED thread locking compound (provided) to bolt threads and re-attach the stainless receiver and use channel locking pliers to snug fit the stainless receiver to the mounting bracket. Note: Do not over-tighten as this may cause the retention bolt to turn. Note: If, during this action, you are unable to appropriately tighten the stainless receiver onto the retention bolt then abandon this action and proceed to the next procedure to replace the Clip-on Brackets.

According to MORryde's Recall 25E026, in part: "thread locking solution will be used." Forest River is using these in production the week of April 14, 2025. Any vehicles in Forest River holding yards with these brackets will be remedied prior to shipment.

Recall Schedule :

Description of Recall Schedule : Forest River has the utmost urgency in our recalls. Forest River will send suspected VIN numbers to our third party vendor that is licensed to pull data on the current owner of the vehicles (as needed) once a formal NHTSA I.D. is provided. Forest River intends on pushing the mailing out as soon as NHTSA provides any correction(s) and an Acknowledgement Letter.
