Descriptive Information : The recall population was determined when a letter from MorRyde (the manufacturer of the defective part) notified us of the issue. A search was performed to identify the RVs we use this part on was identified to develop scope.

The recalled product differs from the non recalled product because the product not being recalled either hasn't been built (which they will be built with the new and correct part) or was placed on hold and fixed prior to shipping. T

Description of the Defect : This is a bracket that is used on the side of an RV that has a receiver for a removable step assembly to clip into. This receiver is installed using a thread locking fluid to retain the assembly. It was found that there are parts that did not have this thread locking compound installed during assembly.

FMVSS 1 : NR

FMVSS 2 : NR

Description of the Safety Risk : If this receiver becomes loose while being used, it can disengage from the fastener that is used to assemble it to the bracket and disconnect from the bracket allowing the step assembly to fall from its use location. This has the potential to cause personal injury if the step is being used when this happens.

Description of the Cause : Failure to use thread locking fluid during the MorRyde assembly process.

Identification of Any Warning that can Occur : The receiver on the bracket can be spun which can cause it to unscrew and detach from the installed bracket.

Description of Remedy :

Description of Remedy Program :	Grand Design as the final stage manufacturer will release a Recall Notice (immediately following NHTSA assignment of a recall number) to all Grand Design dealers and Registered owners. Owners will be instructed to take their vehicle to the nearest Grand Design dealer to have their patio steps repaired at no charge. Owner's that have paid to have this service performed will be reimbursed by Grand Design for any expenses incurred relating to the defect. The remedy is to replace the step bracket with a properly built bracket.
How Remedy Component Differs from Recalled Component :	The Remedy components will be verified by MorRyde to have the required thread locking fluid.
Identify How/When Recall Condition was Corrected in Production :	Grand Design reviewed stock with MorRyde and quarantined any recalled stock. New stock supplied by MorRyde has been verified to meet their requirements for correction.

Description of Recall Schedule :	Owners of affected vehicles will be notified by First Class mail that their vehicle is affected by this recall. In addition, we will post recall information electronically for consumer access. Dealers will be notified of the recall action (by First Class mail and electronically) and will be supplied with repair information and vehicle identification information.
