Description of Defect :

Description of the Defect : MORryde Recall 25E-026 - there is a bracket that is used on the side of an RV that has a receiver for a removable step assembly to clip into. This receiver is installed using a thread locking fluid to retain this assembly. MORryde found that there are parts that did not have this thread locking component installed during assembly.

FMVSS 1 : NR

Description of the Safety Risk : If this receiver becomes loose while being used, it can disengage from the fastener that is used to assemble it to the bracket and disconnect from the bracket allowing the step assembly to fall from its use location. This has the potential to cause personal injury if the step is being used when this happens.

Description of the Cause : The receiving bracket for the step was not built properly with the locking component.

Identification of Any Warning that can Occur : A loose step receiver bracket.

Chronology :

On April 25, 2025, a MORryde sales representative informed KZ of the recall. All affected units in the yard were placed on hold. On April 26th, units in the yard were repaired. On April 27, KZ received official notification via email from MORryde regarding the recall. KZ's safety committee met on May 1st and agreed to issue a recall. No warranty, consumer complaints, or injury claims have been received.

Description of Remedy :

Description of Remedy Program : The remedy is to replace the step bracket with a properly built bracket. All repairs will be completed at no cost to the owner. Reimbursement will follow the general reimbursement plan that is on file with NHTSA.

How Remedy Component Differs from Recalled Component : The remedied RVs will have a bracket that was built with the thread locking compound that will prevent the bracket from coming loose.

Identify How/When Recall Condition was Corrected in Production : The recall condition will be corrected because the new parts will be properly built by MORryde. The properly built brackets will be used in place of defective ones that KZ's received in the past.

Description of Recall Schedule : KZ RV has the utmost urgency in notifying owners about a recall that affects their vehicle. Letters will be sent once all pertinent information has been gathered.
