The scope was determined by reviewing warranty data regarding fresh tank failure (coming free from it's mounted location). This recall population differs from others not under recall by the way the fresh tank was mounted. There are a total of 50 RVs in scope. x5 of these are Paradigm 295MK's and the remaining 45 are Avenue 32RLS'.

Description of the defect or noncompliance:

The defect is in how the cradles that holds the fresh tank in place is mounted to the bottom of the supporting rails vs. resting on.

The safety risk is that the tank could come detached from the trailer and pose a safety risk while traveling by coming loose from the trailer and causing an accident.

Chronology

The original recall - 24V286 is the foundational beginning of this recall. VOQ request from NHTSA sent to Alliance RV on 3/8/2024 (11575973, 11546736). After discussion back and forth with Mr. Nguyen and Mr. Harrison a request for additional information related to these VOQs (provided on 3/15/2024). In reviewing the information together, Alliance RV determined that a recall was in order (determined on 4/19/2024). On March 25th of 2025, Robert Nguyen reached out regarding VOQ 11649914 regarding a tank failure. After review an discussion of data, it was identified that the initial scope for recall 24V286 was off by around 50 RVs. On 5/13/2025 Alliance RV (Bill Martin and Curtis Carlson) along with Mr. Nguyen, Mr. Harrison and Mr. Neff agreed to expand the scope to cover the failures seen outside of the original scope. At this point, on May 13th, 2025, recall 25V318 was submitted and established to ensure proper repair of the fresh tank recall outlined in the recall documents.

Related NHTSA Recall Number: 25V318 this new recall and the original recall this stems from 24V286 In May of 2025, Robert Nguyen, Jonathan Harrison, Joshua Neff, Bill Martin and myself agreed to expand the scope by 50 RVs

Description of remedy program:

The remedy is to inspect and repair the mounting of the tank support. the tank support will need dropped and then reinstalled on top of the rails it would currently be mounted to on the affected product.

How remedy component differs from recalled component:

The remedied component will have the support cradle / cage mounted on top of the support rails, as outlined in the repair instructions.

Identify how/when recall condition was corrected in production:

Ensuring that production plants are mounting these cradles in, what we've identified, as the best practice.
