Chronology

On July 14, 2025, Forest River's Office of Corporate Compliance ("OCC") was notified by the manufacturing plant that installs the 32" and 44" fuel hose extensions to 32" and 44" stretched chassis that they had received a complaint from a rental fleet that experienced fuel line detachments on a 32" and 44" chassis stretch. OCC opened a research item the same day.

On July 15, 2025, OCC contacted the vendor of the fuel hose to inquire about the recent failure.

On July 18, 2025, OCC followed up with the vendor about the failures.

On July 25, 2025, Forest River's Corporate Committee voted to recall.

On August 19, 2025, Forest River is amending the recall to reflect that parts are not available for the remedy currently. An interim notice is being issued. Once the parts become available, we will amend the recall and send out a second notice.
