Certain 2023 through 2025 model year Kia K5 vehicles manufactured from October 3, 2022 through July 24, 2024.

The recall population was determined by a review of supplier, Kia vehicle production and warranty records. The vehicles subject to this recall were not produced in VIN order. Customers seeking information about their specific vehicle will be referred to Kia's Customer Care Center or their Kia dealer.

Defect / Noncompliance Description

Description of the defect or noncompliance:

Due to a supplier quality issue, the C-pillar garnish face plate may progressively delaminate and become loose from the base of the molding. If the vehicle continues to be driven in this condition, the face plate may eventually fall off.

Description of the safety risk, including crash, fire, death, injury:

A face plate that detaches from the vehicle while in motion may create a road hazard for other road users, increasing the risk of a crash.

Description of the cause:

Insufficient application of the adhesive layer between the garnish face plate and base of the molding by the supplier.

Identification of any warning that can occur:

Visually loose, rattle and/or wind noise.

Remedy Type: Replace
Consumer Advisories: Do Not Drive Park Outside
Description of remedy program:
All owners of the subject vehicles will be notified by first-class mail with instructions to bring their vehicles to a Kia dealer. Dealers will replace the affected C-pillar garnish assembly(ies) not previously replaced under warranty with an improved one. Kia will reimburse owners for repair expenses already incurred pursuant to Kia's General Reimbursement Plan filed May 1, 2024.
How remedy component differs from recalled component:
The remedy C-pillar garnish assembly contains a face plate with mechanical retention to the base in addition to the adhesive layer.
Identify how/when recall condition was corrected in production:
Model year 2025 K5 vehicles produced beginning 7/25/2024 contain C-pillar garnish assemblies with face plates that are mechanically retained.
