The recalled Side Air Curtain Assemblies were introduced into production on 12/09/22 and a corrective action was implemented to production on 07/29/25. Affected vehicles have side curtain air bags that may not meet FMVSS 226 requirements.

100,900 Ranger vehicles are affected.

Affected vehicles were built with side curtain air bags that may not meet the displacement requirements of FMVSS 226 S4.2.1.

Chronology

On **June 20**, **2025**, Ford's Critical Concern Review Group opened a concern related to side air curtain deployment. In June 2025, Ford learned of an FMVSS 226 Ejection Mitigation audit test on a 2025 model year Ranger. The test had been conducted at a third-party facility on behalf of the National Highway Traffic Safety Administration and the vehicle had passed the compliance test, however the displacement test result for the right-hand (RH) side of the vehicle was close to the FMVSS limit. Ford and the third-party lab removed the side and air curtain modules from the vehicle and identified an approximately 12mm slit on the RH curtain near the top of the cushion, rearward of the B-pillar trim and forward of the inflator during visual inspection.

From **June to August 2025**, Ford conducted a comprehensive review of the vehicle environment, including B-pillar surfaces, side curtain airbag packaging, and changes made from the start of current Ranger model production in 2024 model year. Ford reviewed the history of all prior Ranger side air curtain deployments, including deployments conducted during the Design Verification (DV) development stage. Finally, Ford conducted new deployment tests replicating the RH failure mode in tests and determined that the cause was the interaction of the airbag with the B-pillar inner reinforcement flange, which could cause a tear and premature pressure loss.

Ford is not aware of any warranty claims, field reports, or Customer Service Reports related to this concern.

On August 15, 2025, Ford's Field Review Committee reviewed the concern and approved a field action.

Ford is not aware of any reports of accident or injury related to this condition.

Owners will be notified by mail and instructed to take their vehicle to a Ford or Lincoln dealer to have a protective shield installed between the side curtain air bag and the inner sheet metal for both right and left side air curtains. There will be no charge for this service.

After installation of the protective shields, the side curtain air bags on affected vehicles will meet FMVSS 226 requirements.
