Descriptive Information:

Some 2024 - 2025MY Dodge Charger vehicles may have been built with an Electric Drive Module ("EDM") that has a mis-installed Park Pawl Return Spring ("PPRS").

The suspect period began on August 2, 2024, when the first suspect vehicle was produced, and ended on April 3, 2025, when the last suspect vehicle was produced. The suspect population was determined using EDM traceability and vehicle production records.

Similar vehicles not included in this recall were built before or after the suspect period or with a properly installed PPRS.

Defect / Noncompliance Description

Description of the defect or noncompliance:

Sections 6.2.2 and 6.2.3 of the Federal Motor Vehicle Safety Standard 114 compliance test procedure for vehicles with transmissions with a "park" position require the vehicle, while on a 10 percent grade, to move no more than 150 mm from the noted vehicle position with the gear selection control in the "park" position once the parking brake and the service brakes are released. Suspect vehicles may move more than 150 mm from the position noted prior to release of the brakes.

Chronology

- On July 15, 2025, the FCA US LLC ("FCA US") Technical Safety and Regulatory Compliance ("TSRC") organization opened an investigation into some 2024 2025MY Dodge Charger and Jeep Wagoneer S vehicles that may have been built with a mis-installed PPRS in the EDM.
- During July 2025, FCA US TSRC met with FCA US engineering and manufacturing to review the issue, understand the failure mode, review customer records and determine the suspect population.
- On July 23, 2025, FCA US TSRC organization recognized an issue existed on certain vehicles related to the rollaway prevention, potentially resulting in a noncompliance with FMVSS No.114.
- On August 28, 2025, FCA US determined, through the Vehicle Regulations Committee, a noncompliance with FVMSS No. 114 exists on all affected vehicles.
