Approximately 3 motorcycles were manufactured with a cardan shaft that may not have been sufficiently hardened according to specifications.

Basis for recall population determination:

Motorcycle assembly information and supplier production records were used to determine the affected vehicles.

Recall component difference to non-recall component:

Potentially affected motorcycles were manufactured with a cardan shaft that may not have been produced according to specifications.

#### **Defect / Noncompliance Description**

#### Description of the defect or noncompliance:

This safety recall involves a cardan shaft which may not have been produced according to specifications. Specifically, the universal joint yoke of the cardan shaft was not hardened according to specifications. This could lead to slipping of the splined connection between the universal joint and the cardan shaft, and a loss of propulsion.

## Chronology

On July 2, 2025, a field case was reported from a non-US market involving a Model Year 2025 BMW R 1300 RT with a cardan shaft where the universal joint had slipped within the shaft, resulting in loss of traction. An engineering investigation was initiated, and the part was collected for analysis.

Analysis by BMW Motorrad, plant Berlin, identified that a limited number of universal joint yokes had been improperly hardened during the manufacturing process.

Further analysis and parts tracking was initiated to identify the potentially affected cardan shafts.

Motorcycle assembly information was reviewed to determine the number and production dates of potentially affected vehicles.
