Descriptive Information:

Some 2024-2025 MY Fiat 500e Battery Electric Vehicles ("BEV") may have been built with missing plugs for the horizontal headlamp aim adjustment mechanism.

The suspect period began on November 2, 2023, when the first 2024 MY vehicles were produced, and ended on May 23, 2025, when vehicles were produced with an inaccessible horizontal headlamp aim adjustment mechanism. Vehicle production records were used to determine the suspect population.

Similar vehicles not included in this recall were built after the suspect period or were repaired prior to release from the vehicle production plant.

Defect / Noncompliance Description

Description of the defect or noncompliance:

Federal Motor Vehicle Safety Standard ("FMVSS") No. 108 S10.18.4 requires that "A visually/optically aimable headlamp that has a lower beam must not have a horizontal adjustment mechanism..." Suspect vehicles allow access for horizontal headlamp aim adjustment.

If headlamp aim is improperly adjusted it may reduce forward visibility for the driver and create glare for oncoming vehicle drivers, which may cause a vehicle crash without prior warning.

Chronology

- On May 20, 2025, Stellantis Europe S.p.A Control Tower was notified of a potential issue during a read-across related to the headlamp aim adjustment accessibility for the 2024-2025 Fiat 500e vehicles.
- On July 15, 2025, Stellantis Europe S.p.A Control Tower organization opened an investigation into a potential noncompliance in 2024-2025 Fiat 500e vehicles.
- From July 15, 2025, through October 8, 2025, Stellantis Europe Control Tower met with Stellantis Europe engineering and manufacturing to review the issue, understand the failure mode, and to determine the suspect population.

- On October 8, 2025, the Stellantis Europe Control Tower organization recognized a vehicle build issue exists on certain vehicles related to the accessibility of the horizontal headlamp adjustment mechanism, potentially resulting in a noncompliance with FMVSS No 108.
- On October 14, 2025, Stellantis Europe S.p.A determined, through the Vehicle Regulations Committee, that a noncompliance to a Federal Motor Vehicle Safety Standard exists in certain vehicles.

FCA US will conduct a voluntary safety recall to install a plug over the horizontal headlamp aim adjustment.
