Similar vehicles not included in this recall were built after the suspect or were repaired prior to release from the vehicle production plant.

Defect / Noncompliance Description

Description of the defect or noncompliance:

Federal Motor Vehicle Safety Standard ("FMVSS") No. 108 S10.18.4 requires that "a cap covering the horizontal headlamps visually/optically aimable headlamp that has a lower beam must not have a horizontal adjustment mechanism..." Suspect vehicles allow access for horizontal headlamp aim adjustment.

Chronology

- On May 20, 2025, Maserati S.p.A was notified of a potential issue during a read across related to the headlamp aim adjustment accessibility for the 2023-2025MY Grecale and 2024-2025 MY Granturismo and Grancabrio vehicles.
- In May 2025 Maserati S.p.A opened an internal investigation.
- From June 2025 through September 2025 Maserati S.p.A reviewed the issue, understand the failure mode, and determined the suspect vehicle population.
- On October 8, 2025, Maserati S.P.A recognized a vehicle build issue exists on certain vehicles related to the accessibility of the horizontal headlamp adjustment mechanism, potentially resulting in a noncompliance with FMVSS No 108.
- On October 16, 2025, Maserati S.p.A. determined, through the Vehicle Regulations Committee, that a noncompliance to a Federal Motor Safety Standard 108 exists in certain vehicles.

Maserati North America will conduct a voluntary safety recall on all affected vehicles to inspect and, if necessary, install one or two caps (based on the headlamp type) to cover the horizontal headlamp aim adjustment mechanism.
How remedy component differs from recalled component:
The recall is not related to part defect but rather an engineering issue where the caps were not released for production. The remedy is a cap to cover the headlamp aim adjustment hole.
