**Descriptive Information:**

McNeilus identified an issue with the Metro Pak units and investigated further on all of its products to see if there are any other models that were non compliant for FMVSS 108. It was identified that the Metro Pak units that were produced from 2021-2025 were missing reflectors as well as clearance and identification lamps at the rear of the vehicle.

### Defect / Noncompliance Description

**Description of the defect or noncompliance:**

The affected vehicles are trucks (refuse vehicles) 30 feet or longer and are not equipped with intermediate and rear reflex reflectors on each side of the vehicle body or clearance and identification lamps at the rear of the vehicle as required by FMVSS 108.

Without the required reflectors and lamps, the overall size and conspicuity of the vehicle may be impacted, potentially increasing the risk of a crash.

## Chronology

In September 2025, in the course of considering whether another model of McNeilus refuse vehicles complied with the requirements of FMVSS 108, McNeilus initiated a review of the lighting on its Metro Pak model vehicle. McNeilus identified certain Metro Pak vehicles that were produced without certain reflex reflectors and rear lighting and continued its investigation to understand whether there were other vehicles without these lamps. McNeilus' investigation concluded that due to an oversight, model year 2021-2025 Metro Pak refuse trucks were produced without certain lamps and reflectors required by FMVSS 108 for vehicles 30 feet or longer in length. On October 29, 2025, McNeilus determined the vehicles do not comply with the requirements of FMVSS 108 and would conduct a safety recall to address the affected units in the field.
