The recalled population includes certain trailers equipped with a rear impact guard with a 66" horizontal member.

Defect / Noncompliance Description

Description of the defect or noncompliance:

The Rear Impact Guards on the recalled population are equipped with 66" horizontal members that do not conform to certain requirements of FMVSS 223 and 224.

FMVSS1: 223 - Rear impact guards

FMVSS2: 224 - Rear impact protection

Description of the safety risk, including crash, fire, death, injury:

Trailers equipped with a rear impact guard that does not meet the performance requirements of FMVSS

Chronology

May 2025 to September 2025: Wabash's compliance teams conducted a compliance review of drop deck trailers that had been classified as Special purpose vehicles or Low Chassis vehicles under FMVSS 224, S4. Wabash reviewed trailer designs and rear impact guards installed and conducted a regulatory analysis that included a review of NHTSA interpretations and rulemaking information to evaluate different populations of trailers.

9/19/25 - A concern was entered into the system to bring awareness to the Product Safety Team (PST) of a potential Rear Impact Guard non-compliance in certain trailer populations.

9/23/25 - The PST reviewed the compliance investigation and, based on concerns of a potential noncompliance with the dimensional requirements, the PST voted to escalate the issue to the Product Safety Committee (PSC).

10/6/25 - PSC met and determined that these trailers may not comply with FMVSS 224 and voted to submit a noncompliance report.

10/14/25 – Wabash submitted a noncompliance report that included this subject population. The report indicated that Wabash was evaluating the potential safety impact of the noncompliant design and anticipated submitting a petition under 49 CFR Part 556, on the ground that the noncompliance is inconsequential to motor vehicle safety.

10/15/25 – 11/3/25 – Wabash conducted testing to evaluate the performance of the rear impact guards. Following this testing, Wabash decided not to pursue inconsequentiality on this population of trailers and to proceed with a noncompliance recall of the subject trailer population.

Wabash will replace subject rear impact guards with guards that comply with the requirements of FMVSS 223 and 224.

How remedy component differs from recalled component:

Remedy components will comply with the dimensional requirements of FMVSS 224 and the performance requirements of FMVSS 223.

Identify how/when recall condition was corrected in production:

Wabash stopped shipping trailers with the steel guard on August 28, 2025. The new guard design with the compliant horizontal member is being validated.
